We were established in 1967 and have been supporting those with disabilities in Portland and the Glenelg Shire ever since.

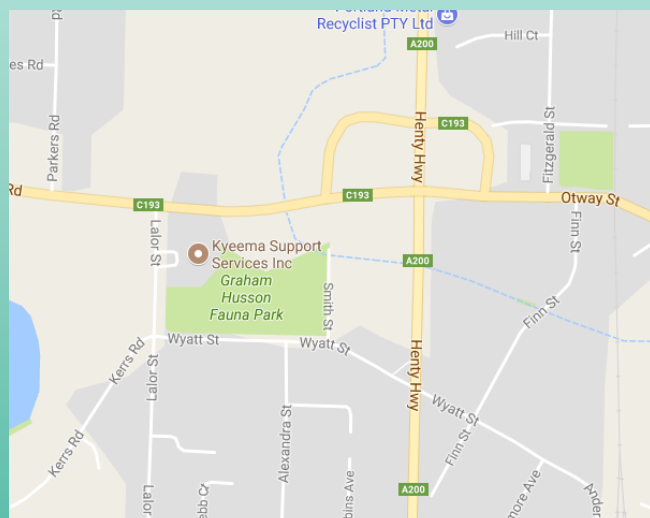
Our vision is for people of all abilities to be able to actively participate as valued members of our community.

What is a Bequest?

A bequest is any asset or property that you give to another in your will.

Bequests can be anything you own, from a small sum of money, to your entire estate.

Why make a Bequest?

Donations of any kind help Kyeema provide the best support possible.

You don't have to be rich to make a difference, every bit counts.

Whether you leave \$100 or \$100,000 we will make sure that we use your bequest to support our participants to the best of our ability.

Where will your gift go?

Anything donated or bequeathed to Kyeema is used to support and better the lives of our participants.

Donations are always used to directly benefit people with a disability, this could include equipment needs, or a contribution to specialist housing suited for those with disabilities.

How can I make a Bequest?

If your will is currently handled by a lawyer, you just need to let them know what you want to bequeath and to whom, otherwise you will need to add a clause to your will.



If you would like to leave a bequest to Kyeema, we recommend you use the following wording,

"I give and bequeath to Kyeema Support Services Inc. (ABN 28 553 192 702) of 50 Lalor Street, Portland VIC 3305 for its general purposes, free from all duties and taxes, _____. An authorised receipt from any authorised officer of Kyeema Support Services Inc. shall form a valid and complete discharge for the executor or trustee."

Types of Bequests

You can make a bequest in many forms, just replace the blank spot in the example bequest with the bottom line from the relevant section below.

A part of your estate

You can leave a specific asset or part of your estate such as a lump sum. Your executor will give the beneficiary exactly what you specify and the gift will not change as time passes.

"the sum of \$_____"

A percentage of your estate

You can leave a percentage of your entire estate. This is useful as it helps prevent inflation from reducing the value of a bequest.

"_____ % of my estate"

A residual bequest

You can leave the remainder (or a portion) of your estate. This will ensure that your family and friends will be taken care of first, and only what is left afterwards will be given to the other beneficiary.

"_____ % of my residuary estate"
